## Regarding “contaminants” in drinking water:

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that the water poses a health risk. In order to ensure that tap water is safe to drink, the Washington State Department of Health and EPA prescribe regulations in water provided by public water systems. The Food and Drug Administration (FDA) and the Washington Department of Agriculture regulations establish limits for contaminants in bottled water that must provide the same protection for public health.

## Sources of drinking water:

Common sources of drinking water—both tap and bottled water—include rivers, lakes and streams (surface water) and wells and springs (groundwater). As water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals and, in some cases, radioactive material. The water can also pick up substances resulting from the presence of animals or from human activity.

#### Reminder:

Any hazardous material that you put onto the ground or in your septic tank could potentially pollute the groundwater. Please help the HMC Management Water System prevent groundwater contamination for this and future generations.

## Where does my water come from?

Your water comes from two wells and is considered groundwater. These two wells are 196 and 200 feet deep, both tapping the same aquifer. Your water is not treated (no chlorination, filtration, pH adjustment, etc).

## Contaminants that may be present in source water include:

- ◆ Microbial contaminants, such as viruses, parasites and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations and wildlife.
- ◆ Inorganic contaminants, such as salts and metals, which can be naturally-occurring or result from urban stormwater runoff, industrial or domestic wastewater discharges, oil and gas production, mining or farming.
- ◆ Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban stormwater runoff and residential uses.
- ◆ Radioactive contaminants, which can be naturally occurring or be the result of oil and gas production and mining activities.
- ◆ Organic chemical contaminants, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban stormwater runoff and septic systems.



# Water Quality Data

## How To Read The Tables:

Your water is tested for more than 100 contaminants for which state and federal standards have been set. **Tables 1 & 2** list all primary contaminants that were detected (in **any** amount) along with their respective Maximum Contaminant Levels (MCLs). Primary standards protect public **health** by limiting the levels of these contaminants in drinking water. **Table 3** shows the levels of secondary contaminants and common water properties of interest to many consumers. Secondary contaminants have no known health effects but can affect the **aesthetic** properties of water (taste, odor and appearance). Secondary Maximum Contaminant Levels (SMCLs) are guidelines only.

## Terms and Abbreviations used:

**Maximum Contaminant Level (MCL):** the highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

**Maximum Contaminant Level Goal (MCLG):** the level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

**Action Level (AL):** the concentration of a contaminant which, when exceeded, triggers treatment or other requirements which a water system must follow.

**Lead and Copper 90th Percentile Value:** Out of every 10 homes sampled, 9 were at or below this level. This must be  $\leq$  the AL or additional steps must be taken.

**ppb:** parts per billion. **ppm:** parts per million.

**N/A:** not applicable **NTU:** nephelos turbidity unit

**Volatile Organic Chemicals (VOCs).** In 2010, your drinking water source was tested for 45 different VOCs. These are by-products of industrial processes and petroleum production, and can also come from gas stations and dry cleaners. We are pleased to report that there were no detections, in **any** amount, of any of these contaminants!

<sup>b</sup> Your drinking water source was granted a 9-year monitoring waiver for Inorganic Chemicals (IOCs) by the Dept of Health. Only one complete IOC sample was required between January 2002 and December 2010 and this was completed in June 2004. Eligibility for an IOC waiver depends on source-specific water quality history and a waiver application. The annual sampling requirement for nitrate cannot be waived.

<sup>c</sup> The EPA recommends 20 ppm sodium as a level of concern for consumers who must restrict their dietary intake.

<sup>d</sup> Equivalent to 4.9 grains per gallon of hardness. 0-75 ppm hardness is considered "soft" water, 75-150 ppm is "moderately hard", 150-300 ppm is "hard" and > 300 ppm is "very hard".

<sup>e</sup> 1.0 NTU is the state's drinking water response level, meaning additional sampling or steps **may** be required, if exceeded.

**Your drinking water source meets all applicable EPA and Dept of Health standards!**

**Synthetic Organic Chemicals.** Your drinking water source was tested for 14 different herbicides, 59 pesticides and 10 insecticides in August 2000. There were no detections, in **any** amount, of any these chemicals. No further monitoring is due for these chemicals until sometime during the new 2011-2019 compliance period.

**Radioactive Contaminants.** Your drinking water source was tested for radium 228 and gross alpha in 2010. There were no detections of either of these contaminants. These can be naturally occurring or the result of oil and gas production and mining activities.
